## About Our Upcoming Speaker: **Herman Cain**



Herman Cain grew up poor in Atlanta, Georgia. Both of his parents struggled to care for him and his brother. His mother worked as a domestic and his father held several jobs, including serving as a chauffeur for the Coca-Cola Co. Cain's parents stressed the importance of education, a lesson he took to heart. In 1967, Cain graduated from Morehouse College with a bachelor's degree in mathematics. He continued his studies at Purdue University, earning a master's degree in computer science. During this time, Cain worked for the U.S. Navy. There he helped design fire control systems.

With his advanced technical skills, Cain became a systems analyst for Coca-Cola. He then moved in 1977 to food giant Pillsbury where he worked his way up to vice president. Switching from information technology to business management, Cain went to work at the company's Burger King division. Cain learned the ropes by manning the grills himself and eventually became a regional vice president for the fast-food chain. In 1986, Cain took on his biggest business challenge. He accepted the post of president and CEO of the failing Godfather's Pizza chain. In fourteen months, Cain managed to turn the pizza chain around, cutting the number of stores by a third and boosted sales at the remaining restaurants. He and other executives later bought the chain from Pillsbury.

In 2004, Cain sought political office for the first time. He failed in his bid to win one of Georgia's Senate seats. Undeterred, Cain threw himself into the race for the 2012 Republican presidential nomination. In August 2011, Cain came in fourth in the Iowa Straw Poll, beating out such better known candidates as Rick Perry and Mitt Romney. He won the Florida Straw Poll a month later.

Today, Cain lives in Sandy Springs, Georgia, with his wife Gloria. The couple have two children and several grandchildren. A devoted fan of gospel music, Cain once recorded his own album of religious songs. He has also hosted his own radio show for an Atlanta station and written several books.

### Advice from the Bench: Judge Brian Amero

#### Henry County Superior Court

Superior Court is less about love and valentines than it is about love lost, forbidden love, lust and perversion. If you've ever sat through a divorce trial with multiple paramours or a sex trial (child molestation, rape, incest, sodomy), you know what I mean.

Unfortunately, the only love we tend to see overflowing in Superior Court is the love of pain killers, opiates, and methamphetamines. These addictions are jealous lovers. They lay claim to your body and soul. They take your family and friends, your career, your skin, your teeth, your sanity and, much too often these days, your life.

In particular, with regard to painkillers and opioids, the Center for Disease Control (CDC) found a continued sharp increase in opioid-involved deaths in 2014, reporting 24,648 such deaths.<sup>1</sup>

Locally, we are seeing a similar increase in opioid addiction and shocking news stories involving allegations of over-prescription.

For those of you who don't know, we have an Adult Felony Drug Court and a Resource Court here in Henry County that can help with this problem. These programs involve individual and group counselling, frequent random drug testing and an incentive and sanction matrix designed to reinforce our cognitive behavioral therapy-based curriculum which is well known to be an evidence-based best practice.

So, if you are representing someone who appears to be the throes of addiction and seems beyond help, my advice from the bench is that you call Craig Ogilvie, the Director of Accountability Courts, and see if you can not only resolve a criminal charge, but perhaps quite literally save a life.

### Til Death Do Us Part



Karen Finnegan sued Joseph Finnegan for divorce in July 2007 after 26 years of marriage. Joe's defense was simple: He claimed that when his heart stopped in June 2004, his temporary death dissolved his marriage. His death was "temporary" because cardiopulmonary resuscitation revived him. In fact, Joe claimed that he later died two additional times, in 2004 and 2005. He therefore filed a motion captioned "Motion to Dismiss on the Grounds that the Defendant is No Longer Married to the Plaintiff Having Been Previously Completely, Although Not Permanently Dead." Since Joe's death wasn't permanent or irreversible, his motion was denied.
